Sapelo Island (SAP) NERR Meteorological Metadata January – December 2015 Last Update on October 16, 2017

I. Data Set and Research Descriptors

2) Entry verification

Data are uploaded from the CR1000 data logger to a Personal Computer (IBM compatible). Files are exported from or LoggerNet in a comma-delimited format and uploaded to the CDMO where they undergo automated primary QAQC and become part of the CDMO's online provisional database. During primary QAQC, data are flagged if they are missing or out of sensor range. The edited file is then returned to the Reserve where it is opened in Microsoft Excel and processed using the CDMO's NERRQAQC Excel macro. The macro inserts station codes, creates metadata worksheets for flagged data and summary statistics, and graphs the data for review. It allows the user to apply QAQC flags and codes to the data, append files, and export the resulting data file to the CDMO for tertiary QAQC and assimilation into the CDMO's authoritative online database. For more information on QAQC flags and QAQC codes, see Sections 11 and 12. Patrick Hagan is responsible for all data management.

3) Research objectives

The principal objectives are to record meteorological information for the Sapelo Island NERR's site that can be used 1) as a reference for meteorological data for research projects on the reserve, 2) to give meteorological context for our quarter hourly SWMP water quality data, and other long term environmental monitoring projects at the Reserve, 3) to observe and characterize important events such as storms, heat and cold waves, droughts, and heavy rainfalls, and 4) to detect trends and characterize climate variability over the long-term

4) Research methods

Campbell Scientific data telemetry equipment was installed at the Marsh Landing station on 02/15/2007 and transmits data to the NOAA GOES satellite, NESDIS ID #3B036592. The transmissions are scheduled hourly and contain four (4) data sets reflecting fifteen minute data sampling intervals. Upon receipt by the CDMO, the data undergoes the same automated primary

QAQC process detailed in Section 2 above. The "real-time" telemetry data become part of the provisional dataset until undergoing secondary and tertiary QAQC and assimilation in the CDMO's authoritative online database. Provisional and authoritative data are available at http://cdmo.baruch.sc.edu.

The 15 minute Data are collected in the following formats for the **CR1000**:

Averages from 5-second data:

Air Temperature (°C), Relative Humidity (%), Barometric Pressure (mb), Wind Speed (m/s), Wind Direction (degrees), Battery Voltage (volts)

Maximum and Minimum Air Temperature (°C) and their times from 5-second data (these data are available from the Reserve)

Maximum Wind Speed (m/s) and time from 5-second data

Wind Direction Standard Deviation (degrees)

Totals:

Precipitation (mm), PAR (millimoles/m²), and Cumulative Precipitation (mm)

Sensors are visually inspected on a monthly basis and are removed and recalibrated by the manufacturer on the following schedule:

- Temperature/Humidity- yearly recalibration
- Rain Gauge- yearly recalibration
- Wind Speed/Direction- yearly or every 2 years (depending on the sensor)
- Barometric Pressure- every 2 years recalibration
- PAR- every 2 years recalibration
- CR1000-every 5 years (required beginning 2014, one year initial grace period)

5) Site location and character -

The site is located at N 31deg 25.068', W 081deg 17.721', about 15 feet above sea level. All sensors are mounted on a 10m-aluminum tower located in the northern corner of the Marsh Landing parking lot on the southwest corner of the island. The parking lot surface is approximately a meter above the surrounding marsh. The heights of the sensors on the tower are as follows:

It is bordered with salt marsh to the north and south with transition into pine forest occurring 1/2 mi to the east. On the immediate west lie the Duplin River and the ferry dock, which is also the location of our lower Duplin and marsh Landing Water Quality sampling sites. The station is well exposed to all winds and weather with little blockage and no shading. This region is subject to multiple severe weather phenomena partially due to the proximity to the ocean. These phenomena include severe summer thunderstorms, which can cause drastic, localized drops in pressure, temperature, and heavy rains; powerful fall and winter frontal systems carrying prolonged strong winds (usually NNE), drastic and sudden drops in temperature and pressure, and long, steady rains; and finally the late summer and early fall hurricanes. It must be noted that due to the remote location

and proximity to the ocean our weather patterns can vary greatly from those on the mainland, particularly temperatures which tend to moderate due to our being surrounded by water. The nearest sites for comparison is the Grays Reef NOAA weather Buoy located about 20nm east of Sapelo Island and Glynco airport located approx. 30 mi to the SSE.

6) Data collection period -

The data collection period for 2014 runs from Jan 1, 2014 @00:00 to Dec 31, 2014@23:45 Data collection began at this site in September 2002.

10) Coded variable definitions

11) QAQC flag definitions – This section details the automated primary and secondary QAQC flag definitions.

QAQC flags provide documentation of the data and are applied to individual data points by insertion into the parameter's associated flag column (header preceded by an F_). During primary automated QAQC (performed by the CDMO), -5, -4, and -2 flags are applied automatically to indicate data that is above or below sensor range, or missing. All remaining data are then flagged 0, as passing initial QAQC checks. During secondary and tertiary QAQC 1, -3, and 5 flags may be used to note data as suspect, rejected due to QAQC, or corrected.

12) QAQC code definitions – This section details the secondary QAQC Code definitions used in combination with the QAQC flags above.

QAQC codes are used in conjunction with QAQC flags to provide further documentation of the data and are also applied by insertion into the associated flag column. There are three (3) different code categories, general, sensor, and comment. General errors document general problems with the CR1000, sensor errors are sensor specific, and comment codes are used to further document conditions or a problem with the data. Only one general or sensor error and one comment code can be applied to a particular data point, but some comment codes (marked with an * below) can be applied to the entire record in the F_Record column.

13) Other remarks/notes

Data are missing due to equipment or associated specific sensors not being deployed, equipment failure, time of maintenance or calibration of equipment, or repair/replacement of a sampling station platform. Any NANs in the dataset stand for "not a number" and are the result of low power, disconnected wires, or out of range readings. If additional information on missing data is needed, contact the Research Coordinator at the reserve submitting the data.

Small negative PAR values are within range of the sensor and are due to normal errors in the sensor and the CR1000 Datalogger. The Maximum signal noise error for the Licor sensor is +/- 2.214 mmoles/m2 over a 15 minute interval.

Relative Humidity data greater than 100 are within range of the sensor accuracy of $\pm 10^{-3}$ %.

Data recorded for all parameters (with the exception of cumulative precipitation) at the midnight timestamp (00:00) are the 15 minute averages and totals for the 23:45-23:59 time period of the previous day. Cumulative precipitation data at the midnight timestamp (00:00) are the sum of raw (unrounded) precipitation data from 00:00 to 23:59 of the previous day. Summing each individual 15-minute total precipitation value from the same period will result in small differences from cumulative precipitation due to rounding. It is especially important to note how data at the midnight timestamp are recorded when using January 1st and December 31st data. Note: Cumulative precipitation is no longer available via export from the CDMO. Please contact the Reserve or the CDMO for more information or to obtain these data.

CDMO Edit 10/16/2017: There were noticeable changes in PAR values following the swap to a freshly calibrated sensor (assumed to be accurate) on 02/02/2016. The sensor (Q49437) was retired after removal and was not post calibrated to check for drift. Since drift

numbers are not known all PAR data 1 year prior the sensor swap, from 02/02/2015 00:15 to 02/02/2016 13:00 are flagged and coded as <1> SSD CSM. PAR data for the remainder of this deployment, 10/08/2014 15:00 - 02/02/2015 00:00 are flagged and coded <0> CSM unless otherwise flagged and coded, and users should note that drift for that period may have exceeded acceptable limits as well. If users are comfortable assuming that drift was linear (in a real world environment it is unlikely to be entirely linear), these data may be 'corrected' for assumed linear drift at the user's discretion using manufacturer's instructions.

In addition to the above flagging and coding, all PAR data, unless otherwise flagged as missing or rejected, are flagged as suspect due to slightly elevated night time readings when we should be seeing zero. The cause is not fully understood but daytime readings could also be slightly off by +/- 4 mmoles/m2 over a 15 minute interval.

The tipping bucket funnel was blown off in a squall on 3/12, it was found and replaced on 3/17. Data are considered suspect beginning 12:45, following a jump in wind speeds, until 3/17 13:45 when the funnel was replaced. It is believed that no precipitation occurred during the time the funnel was missing, however, the data are still flagged as suspect. Precipitation data at 14:00 were corrected to 0.0 after an accidental tip during funnel replacement, cumulative precipitation were corrected from 14:00 through the end of the day 3/18 00:00. Although the data are flagged as corrected, they are still considered suspect due to an out of calibration CR1000.

All parameters are flagged and coded as <1> SOC CSM from 02/15/201500:00 - 4/24/2015 12:15 due to the data being collected with an out of calibration CR1000. All Reserves were required to have their loggers calibrated during 2014 with a deadline of 02/15/2015.

Data are missing or rejected from 4/24/2015 12:30 - 05/05/2015 12:30. The CR1000 was removed and sent to Campbell Scientific for calibration. It was replaced with a new logger on the same day as it was removed, 4/24/2015, however, it did not log correctly until 05/05/2015 13:30.

On 7/23 @18:45 a precipitation event was recorded, it is believed that the funnel was clogged and suddenly cleared resulting in the recorded event. Total precipitation is considered suspect 17:30 -18:45, just prior to the event since we don't know when the clog formed and cumulative is considered suspect form 17:30 through the end of the day at 7/24 00:00.

All PAR data, unless otherwise flagged as missing or rejected, are flagged as suspect due to slightly elevated night time readings when we should be seeing zero. The cause is not fully understood but daytime readings could also be slightly off by +/- 4 mmoles/m2 over a 15 minute interval.
